#### **Minimum Member Qualifications:**

- At minimum members must be high school graduates, GED recipients, or working on attaining a high school diploma or GED during their term of service
- Be 17 years or older (17-year-old applicants require parental consent)
- Pass a national service criminal history check
- Hold one of the following citizenship statuses: US citizen, US National, Lawful Permanent Resident
- Have a valid driver's license

#### Position #1 & #2: Land & Water Steward

<u>Position Outline</u>: Members help the organization carry out projects, including collecting samples and analyzing data. They will help extend our research into the community and support our educational programs about native shores/vegetation. GIA members will gain leadership in selecting and implementing projects, and increase program awareness within the IGL community. Additionally, members will enhance their skill sets and increase diversity in the workforce in natural sciences.

#### **Member Duties:**

- Complete Green Iowa AmeriCorps performance metrics in collaboration with host site
- Maintain records of service projects in Green Iowa AmeriCorps Reporting Logs
- Submit Quarterly Reports of activities
- Maintain a detailed timekeeping record of service hours and activities
- Complete a Professional Development Project
- Participate in mandatory AmeriCorps Trainings (Orientation and Life After AmeriCorps Training) and National Days of Service (MLK Day and September 11)

## The ideal candidate will possess the following skills:

- Bachelor's degree in environmental science, sustainability, biology, or closely related fields is preferred.
- Field-based experience with collection of environmental samples, processing of samples, or other ecological restoration work is strongly preferred.
- Computer proficiency (word processing, spreadsheets) is required.
- Ability to travel in northwest lowa for fieldwork; ability to work in harsh field conditions or inclement weather is required.
