Host Site Overview:

The Waterloo GIA host site consists of a partnership between the <u>Black Hawk County Solid Waste</u> <u>Commission</u> and the <u>Black Hawk County Public Health Department</u>. The mission of this site is to provide residents of Black Hawk County with an understanding of the environmental, social and financial implications of their decisions, to identify and inform on sustainable alternatives to negative impacts, and to change behavior to reduce our environmental impacts and improve human health.

Position: GIA Education and Outreach Coordinator **Position Outline:**

GIA SS members in Waterloo Schools site will create and lead sustainability programs on topics such as school gardening, compost, food waste reduction, reuse and recycling education, pollinator habitat, and more in K-12 Waterloo schools and other community organizations. Members will assist with identifying, measuring and monitoring environmental impacts, offer strategies to reduce those impacts and participate in community outreach events focused on public health initiatives.

Member Duties:

Anticipated Duties in alignment with the goals of the Black Hawk County Public Health Dept

- School garden education and maintenance as well as compost support will occur during Spring and Summer seasons.
- Collaborate with 11-month Green Iowa members to provide sustainability education at Waterloo School District summer school programming, summer feeding sites, and early childhood centers.
- Your role will be to help build a schoolwide culture of health from hallways, classrooms, cafeterias and outdoor play spaces that celebrate healthy food.

Anticipated Duties in alignment with the goals of the Black Hawk County Solid Waste Agency

- Develop and execute projects within Waterloo school district and throughout Black Hawk County that will promote reduction, reuse and recycling of materials.
- Promotion of growing foods, food preservation and education on labeling and the environmental impact of the food chain.
- Illegal dumping and litter outreach and education specifically with the development of a community survey to gather perceptions related to waste diversion efforts throughout Black Hawk County.
- Working with UNI (and perhaps other local universities) to decrease the amount of waste generated at the end of the academic year.
